Zeigler rabbit diets can be fed ad libitum. The amount of feed consumed by rabbits will vary according to age, size and reproductive status. For instance, a pregnant rabbit will consume from 150-200 grams per day and during lactation this may increase to 200-400 grams per day. Limited feeding is acceptable to prevent obesity.
